How to complete the on-line “Internet Banking Registration Form”

- 1. Client Number** This is your individual client number.
(It may be appropriate to speak to a B&E staff member to obtain the appropriate client number.)
- 2. Surname** This is the surname of the client registering for Internet Banking.
- 3. Given Name(s)** This is the given name(s) of the client registering for Internet Banking. Please include all given name(s).
- 4. Nominated Login Name** This is the login/name you nominate to access Internet Banking. This number can be your client number or can be alphanumeric but must contain at least 2 numbers
- 5. E-mail Address** This is an optional field. Only complete this field if you would like B&E to store this information.
- 6. Accounts Details/Daily Withdrawal Limit** This field only requires completion if you wish to restrict access to any accounts linked to your client number. You may also maintain a Daily Debit (Withdrawal) Limit per account otherwise the default limit will apply. Please refer to Clause 5.2 of Part G “Terms and Conditions – Cards and Electronic Banking” in our Product Disclosure Statement for details.
- Indicate the account number and then nominate the Daily Debit Limit (if applicable) and one of the following options :
- Full Access – Will allow you to see the account details and transact against the account.
- Enquiry Only – Will allow you to see the account details but not process transactions or modify in any way.
- No Access – Will not allow you to view, access or modify the selected account.
- 7. Office Use Only** Leave this section blank. Upon registration a B&E staff member will complete this section.
